a negative impact on public sector unions by eliminating fair-share fees for non-members, thereby reducing the financial resources available for collective bargaining and advocacy efforts. Proponents of Janus hoped it would lead to decreased union membership and influence, posing challenges to our ability to effectively represent the interests of all employees.

Despite these challenges, our increased membership demonstrates our resilience and determination to overcome obstacles together. Let us continue to stand united in advocating for fair treatment, better working conditions, and a brighter future for all members.

Advocacy Day

Shout out to Binghamton Chapter members who traveled to Albany on March 4-5 to effect legislative change including Andre Mathis, Troy Norton, Robert Mess and Nikita Robinson. Statewide we had double the number of people we had in the past and fought to save Downstate, fund our 18 distressed campuses, and to fix the retirement Tier 6.

As crises have hit at Downstate, Potsdam and Fredonia we have been able to marshal our strength and focus as never before. UUP is gaining support in the legislature and in the media while Chancellor King has been losing support. If we allow them to take out one of our hospitals in the middle of Brooklyn then no campus is safe.

The Assembly and the Senate have released their one house bills and they are favorable to us. With Senator Zellnor Myrie's bill in the senate that would effectively save downstate. The Assembly's 1 house bill also supports keeping downstate open.

In terms of the non-hospital campuses. We asked for \$138 million in additional operating funds, the Senate has given us \$100 million and the Assembly has given us \$186 million. This is not a final budget so now is when our advocating is most needed. We have unprecedented access to the governor's staff and are using that influence to achieve our goals. We also have access to Senators and Assemblymembers across the state including locally Senator Lea Webb and Assemblymember Donna Lupardo here in Binghamton. Last year we benefitted from a drawnout budget process, but this year *Speaker* Carl Heastie wants to wrap up the budget on time and so does the governor.

Statewide we are keeping pressure on governor regarding downstate. TV Ads are running in Brooklyn and Albany, hard-hitting and it's having some effect. The secretary to the governor has shown interest in the wording of our bill.
