Supporting the Dr. William F. Stier Jr. Undergraduate Sport Management Scholarship

As a friend and colleague of the late Dr. William F. (Bill) Stier Jr. it gives me great pleasure to be granted another opportunity to acknowledge Dr. Stier's superb professional and personal accomplishments over his more than three decade career as a sport management professor here at The College at Brockport and a dedicated UUP member. Doing so allows me to also continue to promote the very important undergraduate sport management scholarship that I initiated in Dr. Stier's name (see methods of giving below). Dr. Stier's accomplishments included serving as our athletic director, chair of the Department of P.E. and Sport, director of the Sport Management Undergraduate Program and Graduate Athletic Administration Program, author of 28 books and 383 articles, serving on no less than 15 journal editorial boards, serving as editor in chief of two international and one national journal, conducting workshops in 18 countries and the delivery of 254 speeches throughout the world. Despite the fact that the aforementioned accomplishments are beyond extraordinary, in my view, it was Dr. Stier's years of dedication to shaping the lives of students that was his greatest accomplishment. Dr. Stier's high expectations of students were a reflection of the premium standard of student success held as a core value by The College at Brockport, UUP, and SUNY. I can't think of a better way to honor Dr. Stier's dedication to his students than through this sport management undergraduate sport management scholarship. What follows is a letter written by sport management alum James Williamson who expresses his profound admiration and respect for Dr. Stier as a sport management professor, mentor, and overall citizen.

Here are the words from sport management alum and assistant baseball coach, James Williamson recounting how Dr. Stier affected his and other sport management students' lives:

As a graduate of the Brockport sport management program, it's hard to put into words the effect Distinguished Professor Emeritus, Dr. William F. Stier, Jr., had on me both personally and professionally. I was deeply saddened when I learned of Dr. Stier's recent passing. It made me reflect on a mentor and educator who undoubtedly touched the lives of so many individuals in much the same way.

Dr. Stier changed the way I viewed the world. Surely, you recall his unique approach with students who arrived late to class, those who didn't bring a pencil for a Scantron test, or students who wore black ankle socks to those nerve-racking exit interviews. It was that "old school" philosophy coupled with his unwavering professionalism that resulted in his renowned career as a sport management professor for more than 30 years.

As important as Dr. Stier was to generations of Brockport students, I feel it's equally important to honor his memory in a very meaningful way. His longtime friend and sport management colleague, Dr. Robert C. Schneider, has already initiated that process by establishing the William F. (Bill) Stier, Jr. Sport Management Scholarship.

Hope

During the past eight months, I have had the opportunity to serve as a member of the College Climate Survey Committee as well as on a taskforce charged with reviewing the operation and needs of the Office of Human Resources. In addition, as the UUP President, I have had the occasion to be involved in many aspects of the College that have included employees that not only are professionals and faculty but employees from most of the other areas of the college community to include even those that are classified as MCs. This wide range of involvement and engagement has given me the opportunity to gain a level of insight and knowledge relative to many concerns and levels of job satisfaction. It in turn has allowed me an opportunity to take an unofficial pulse of the campus morale level.

Two years ago I expressed, during the College Faculty and Staff Convocation, that as we continue to sail along with our sights set on admirable and lofty goals such as a Nationally Recognized Comprehensive Master's Institution and a 25 million dollar giving campaign, that there were then and continue to be leaks in the bottom of the ship and the leaks are focused on how we treat people. This past fall, during convocation, I shared as an introduction to this new academic year a reminder and a charge to those of our leadership that whatever our goals, concerns or needs are, it is going to be the people of our campus that bring it all together and make it happen. I also added that we need to hold on to that principal; that it's how we treat the people that make our college what it is.

Some years ago as we embarked on the road to changing the direction and culture of our college, a new president said in the start of his term that if we treat people right, we as a college could accomplish anything we set our collective minds to do. He emphasized this principal of just treat people right. It is with a great deal of agony for me to say that we seem to have lost this idea and somehow we're going to have to find our way back to it, if we are to move forward.

To conclude this expose, there is a principal that permeates all institutions, whether they are secular or religious, and that principal is "truth." My version says truth is the foundation of any lasting movement or in other words, "the truth shall make one free." Well, in any assessment, measurement, evaluation, restructuring, reorganization, activity, etc. the foundation of this effort must begin by establishing some truth. Let me be direct and say, and I do hope that I am wrong, but it appears that many are denying or even hiding the truth as to the actual or real conditions or concerns of our College Community. Some seem to even refuse to accept that the campus morale is of concern.

Now that I have expressed some of the reality we face, I want to say that we now have great opportunities to really change our circumstances and move forward in a direction that recognizes that our most valuable asset is human capital and it just makes sense that we take good care of our most valuable asset. It is also important that I end this on a positive note by pointing out that there have been positive efforts that can or should be shared regarding several of the issues we are facing. We have begun to face and address the difficulties of an understaffed and overworked Human Resources Office. This includes a new HR director and a committee that includes outside consultants to assist in the development of a new HR Office and HR practices. In addition, there is the work of the Campus Climate Committee of which I am holding out that the leadership of our college will indeed accept the true finding of what you have expressed in the climate survey and then take the "oh" so necessary actions that will contribute to a climate of trust, equity, and just plain fairness. So to conclude, there is a lot needed to be done but if each of you would do your part as we work together and to speak up about things that are just not right and offering these things that are good then we can move forward to getting back on the right path.

Fall 2014 Delegate Assembly

The Fall Delegate Assembly took place Oct. 17-18 in Albany. The DA meets three times a year. It is comprised of all UUP chapters. Many of the participants are chapter officers. Active chapter members often attend. Most attendees are also members of various UUP committees (i.e., Labor & Higher Education, Women's Rights, Scholarship, etc.) which hold meetings at the DA.

Pres. Fred Kowal in his address, and in his meeting with the chapter presidents and vice-presidents, proposed a pro-active program to address the issues of SUNY quality and accessibility. Fred does not want UUP to merely react to the Chancellor's proposals, but to be in front in advocating programs which truly better SUNY. The UUP program calls for more adequate funding of SUNY, hiring more full-time tenure track faculty, fighting the assault on tenure, and improving treatment of contingents. The insufficient level of state funding of public higher education must be corrected by legislators.

Jamie Dangler, statewide VP for Academics, spoke about UUP efforts to press for an educationally sound expansion of online education, faculty oversight of curriculum, and an end to the increasing privatization of SUNY's educational operations. Member's intellectual property remains a pressing issue in the context of Open SUNY. Teacher certification and preparation has been harmed by actions of the Chancellor and the State Education Dept. (SED). The SED's ill-planned top down changes have meant fewer students receiving certification, and dramatic declines in teacher education enrollment and applications in the vast majority of public and private colleges in the State. The SED directives contained unreasonable timelines and overlooked the importance of effective decision making by educational professionals.

Jeff Zuckerman from VOTE-COPE gave an enthusiastic presentation with Q & A's. We are State employees. We want legislators in Albany to be on our side. In political contributions, unions are outspent 15-1 by corporate interests. Corporate donors are seeking to take away retirement security, pension protection, and collective bargaining rights. The most stalwart protector of our members is contributions to VOTE-COPE. A documentary film on the extreme right-wing Koch Brothers was shown. Some of the producers of this award winning documentary are adjuncts at SUNY-Purchase. They led a lively post-film discussion.

Edison Bond, the statewide Membership Development Officer announced he was resigning. His new career will be as a minister.

Near the end of the DA, there are several resolutions, some dealing directly with SUNY, some with higher education, and some with political issues. A resolution from the Affirmative Action plus the Women's Rights committees resolved "in condemning the human rights violations and crimes against WOMEN (caps added) committed by Islamic extremists". A motion to replace the word women with humanity was soundly defeated. Mmm, gender equality?
