## Article from President Michelle Toth

### UUP Heading into Contract Negotiations

Our current contract is up as of this summer, specifically July 2022.

Myself as chapter president and our ad hoc negotiation committee reps Rohit Rampal (academic) and Deb Brunner (professional) submitted our campus report summarizing the issues from our campus to the negotiations team. We also participated in the negotiations committee meeting Feb. 4 and 5, where reps from all the campuses meet to discuss and help prioritize member issues for the UUP Negotiations Team.

While the UUP Negotiations team will meet with the Governor's Office of Employee Relations (GOER) to start negotiating the new contract this spring, as it has happened in the past, we will likely not have a ratified contract by the time our current contract expires. When this happens we continue forward with our current salaries and healthcare. What is affected is the funding for joint labor/management programs and grants (PDIA, Dresher, etc...).

We will provide ongoing updates as we move through this process.

While the formal negotiation process gets started, we all have a role to be active and vocal about the issues we will be negotiating for including: better compensation, broader telecommuting options, pathways for contingents for full-time or permanent positions, better access to needed healthcare - including mental health, and so many more. We will be sharing ways you can participate as we move forward in this process.

### Morale, Stress, and what UUP can help with

In the short time since taking on the UUP chapter president role in Nov., I have been increasingly aware of members' dissatisfaction and frustration with working conditions, shifting and increasing workload, and inconsistent approval of leaves and telecommuting options. Unfortunately we are hearing of these issues after members have reached their limits and have already decided to resign, leave campus and take other jobs, or retire.

While UUP does have limits on the scope of what we can do, (much of this is the purview of Management), we are here for our members and we encourage you to reach out to us when these sorts of changes are being made. We are here to help.

- It is appropriate to reach out to UUP when there are changes to your workload - preferably before it is a done deal and you have signed off on it.
- If you have any questions about the performance review processes.
- Concerns about use of leave time.

## Article from Vice President for Academics Dan Gordon

Since this is our first newsletter, allow me to introduce myself. I am Dan Gordon, VP for Academics for UUP's Plattsburgh Chapter. I am also a professor of music and have been a member of the faculty since 1994.

I wear a number of different hats in my role as UUP VP for Academics, but I spend most of my time dealing in some way or other with performance reviews (evaluations). I am engaged in several aspects of the evaluation process to assure that it follows policies and procedures properly. In collaboration with management, we have made a number of recent changes to the evaluation procedure for academics. Among them are that part-time faculty are now evaluated only by chairs and deans; and departments that cannot provide the minimum number of members for its Peer Review Group (PRG) now choose members from within their division rather than depend of the External Review Panel (ERP) to supply them. These changes have streamlined the evaluation procedure and have taken a considerable burden off Peer Review Groups and the External Review Panel. If you serve in either of these capacities, you likely have noticed that your workload in them is considerably less than in the past.

Covid has posed a number of challenges for academics. Statewide meetings with VPA's (Vice Presidents for Academics) have addressed them in weekly meetings since the beginning of the pandemic. The most significant covid-related change to evaluations is that all tenure-track academics had their tenure clocks extended by one year in 2020 unless they opted out of the extension. While the extension was only on a one-time basis, I advise anyone whose teaching, scholarship, and/or service has been affected by covid to discuss these issues in their next file submission.

We are also working on the transition to electronic evaluation files. We are in the process of choosing a vendor and hope to have upcoming evaluations completely electronic. Education and implementation of these will be a project for all of us. But the time has come for electronic files.

I've learned that many of you have a much deeper understanding of matters that are meaningful to you than I may ever have and I'm grateful for your patience in educating me along the way. Thanks to former VP's for the mentoring and thanks to you for your support as we work together to further our interests to improve our pay, benefits, relationships, and work-life balance.
