1. Treasurer's Update

- a. As of December 1, 2024, we have \$9859.61 in our UUP checking account.
  - i. We received our September allocation. After subtracting the release time deduction for the chapter president, we deposited \$1,013.67 in our checking account.
  - ii. It was discovered that UUP Statewide made a mistake in calculating our allocation, and we will receive an additional \$432.67 with our January allocation to correct this mistake.
  - iii. Recent significant expenditures include:  
PUUP portion of North Country Retreat Expense (8/15/2024) (\$516.89),  
Office supplies (shredder) (\$154.55)
- b. Our Good & Welfare fund is currently at \$2,109.11.
- c. Our allocations are based in part on the total number in our chapter bargaining unit, so here are the numbers for the last two years, for anyone interested:
